Allen Richardson, in association with Passports Educational Travel of Spencer, Mass, is organizing a nine-day Horological tour of England starting on May 16, 2011. The tour includes a visit to The British Museum, a Thames river trip to the National Maritime Museum in Greenwich, the Tower of London, Westminster Castle and Houses of Parliament, and a walking tour of the area associated with Jack the Ripper. The tour will then travel by train to Liverpool, and includes a visit to the Prescott Museum and a visit to the Guild Hall and Museum of the Worshipful Company of Clockmakers. The tour will wind up with a shopping trip to Camden Market and the Antique shops on the Portobello Road. The price for the tour includes airfare, all meals, lodging (3 and 4 star hotels), and ground transportation at \$3,388.00 per person.
