Dues will be raised from \$9.00 per year to \$10.00. Mart fees will be raised as follows:

Advanced Registration from \$16.00 per person to \$18.00 - Children (Ages 5-17) from \$7.00 to \$9.00 MART Tables From \$18.00 each to \$20.00 each - Walk In Registrations from \$20.00 to \$22.00 per person Early Birds from \$12.00 for 1 or 2 members to \$15.00 and 3 or 4 from \$20.00 to \$23.00 Mart Tables (Chapter 1 members Only) from \$20.00 to \$22.00 each - Early Birds from \$13.00 to \$15.00

The Council is aware of the hardship this may put on some of our Members but the increases were kept as modest as possible.

- Indicate whether you will, or will not be staying for Lunch.
- Indicate whether you need a fruit plate rather than a regular Luncheon .
