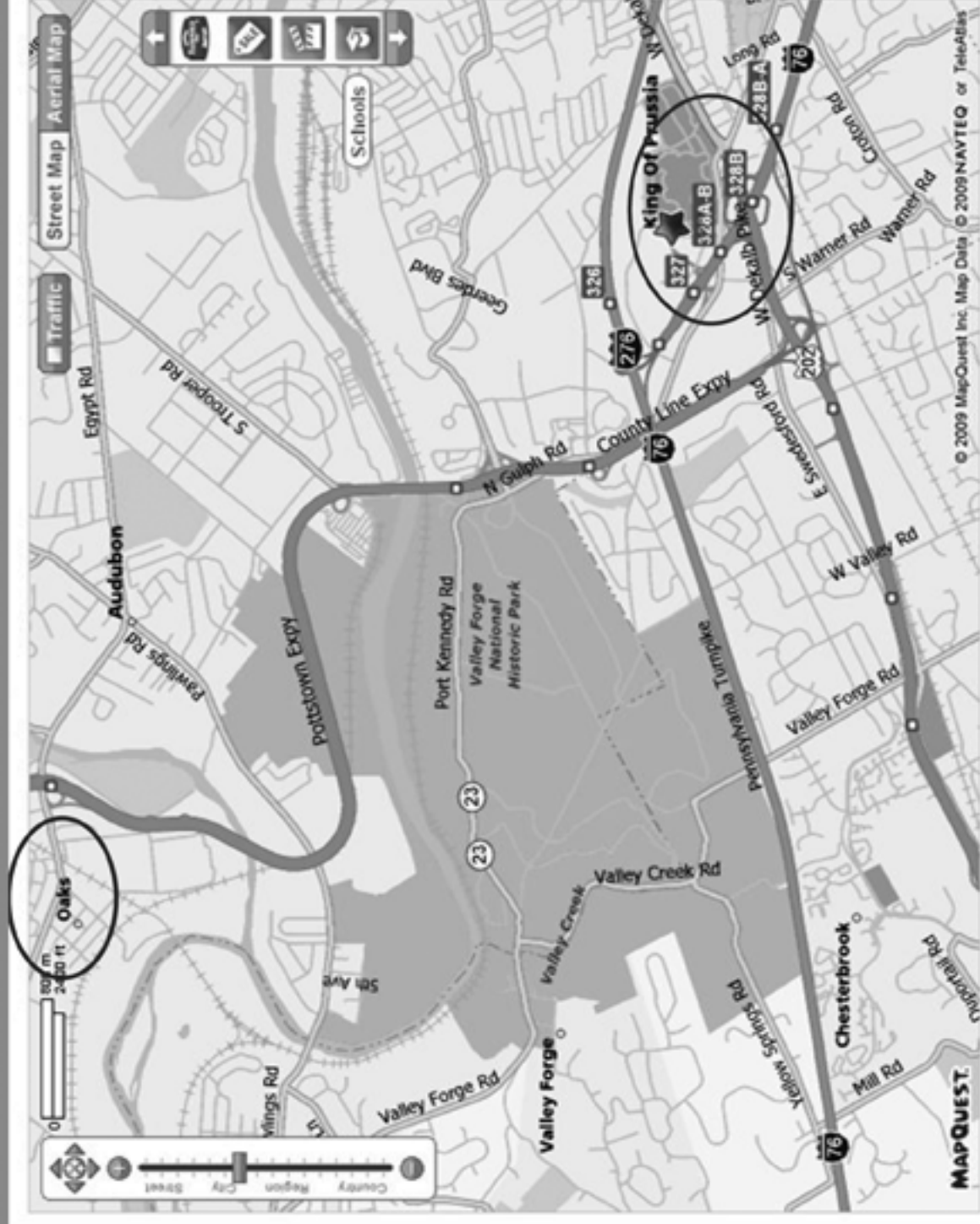

From Rt. 76 (Schuylkill Expressway)

- Follow Rt. 76 west to King of Prussia
- Exit to Rt. 202 South (West Chester)
- Stay in right lane for Rt. 422 West (Pottstown)
- Exit Rt. 422 at Oaks, left onto Egypt Road
- Left at Station Ave. (3rd light)

Follow signs for the Expo Center

From PA Turnpike

- Exit at Valley Forge and stay to the right
- Exit Rt. 202 South (West Chester)
- Stay in right lane for Rt. 422 West (Pottstown)
- Exit Rt. 422 at Oaks, left onto Egypt Road
- Left at Station Ave. (3rd light)

Follow signs for the Expo center
