THE WORKSHOP: DAVE GORRELL — The topic will be "**Pivot Polishing.**" Four methods of pivot polishing will be demonstrated; this will be a "hands-on activity." Bring at least three clock wheels that have bad pivots—you will be encouraged to use all four of the polishing methods. Spectators are discouraged and will be harangued.

FOR LUNCH. We can seat only 150 people at the Luncheon.



- Left at Station Ave. (3rd light)
