The November Cancellation

Chapter one has always prided itself on never, ever canceling a meeting. However, it is often said at various times and by various people both famous and infamous, "never say never". The meeting that was rescheduled to November the 6th had to be canceled. Due to a problem in the plumbing system the Expo Center presented us with several choices, none of which were desirable. We were given three possible scenarios; 1. Move the meeting to the 13th of November, 2. Hold the meeting with the hope that the system would be up and running by the 6th, 3. Cancel the meeting and concentrate on the Dec. 11th meeting. The first option was rejected because it would conflict with the New York Chapter 2 Meeting. The second option was considered too much of a gamble to be taken seriously. This left us with the only viable option, cancel the Nov. meeting. We gave this decision every consideration and we spent several days emailing each other and going over all of the possible ramifications of this decision. It seemed to all that the only reasonable choice was to cancel. We deeply regret any and all inconveniences this may have caused our members. We made every effort, and went to great expense to contact each and every one of you. We sent out 2,654 snail mail and 1757 email notices of the meeting's cancellation. If we missed you we are sorry. We hope that this sort of occurrence never happens again. Fortunately we had enough time before hand to get the word out. We also learned that the process of canceling a meeting is not an easy one, it requires at least a week of discussion to get Council consensus, and at least a week to nine days to get the mailings out. This therefore makes canceling meetings for short term reasons, like weather, almost impossible. Consequently our previous policy of never canceling meetings due to inclement weather will have to remain as it has in the past.

One Day Class on Clock Case Stripping and Refinishing

Our One Day Class on Clock Case Stripping and Refinishing will be held on the 10th of December at Oaks. Those interested in joining us need to register with the Instructor and provide a small wall clock or mantel clock that needs refinishing or "brightening." The cost of the class is \$10.00 per student and a Pizza and soda lunch will be provided. The class will start at 10AM and will end around 5 P.M. it will also be somewhat messy so dress appropriately. The class will include: evaluating whether a case needs refinishing, brightening or left alone; identifying the various types of wood used in the production of clock cases; how to make minor repairs prior to refinishing; how to identify the type of finish originally used on the case; how to apply stain and the final finish; plus much much more. Kindly let the instructor know the case you are bringing so that he can provide the proper materials.
