#### DIRECTIONS to the Holiday Inn, Fort Washington

#### From Pittsburg and points west:

Take I 76 East (Penn. Turnpike) towards Philadelphia. I 76 East becomes I 276 East. Take Exit 339 Fort Washington. After the toll Plaza head straight on to Pennsylvania Ave. about ¼ mile. The Holiday inn will be on your Left.

#### From Wilmington and Baltimore and points South

Take I 95 North towards New York. Merge onto I 476 North at Exit 7 towards Plymouth Meeting. Take Exit 20 for I 276 East/ Pennsylvania Turnpike. Take Route 309 Exit 339 towards Fort Washington. After the Toll Plaza bear to the Left and head straight for 1/8 mile on to Pennsylvania Ave., the Holiday Inn will be on your Left.

#### From Downtown Philadelphia

Take John F. Kennedy Blvd. / Rt. 3 West. Merge onto I 76 West toward Valley Forge. Merge onto I 476 North; at Exit 331 B towards Plymouth Meeting. Take Exit 20 for the I 276 East/ Pennsylvania Turnpike. Take the Route 309 Exit 339 toward Fort Washington. After the Toll Plaza bear Left on to Pennsylvania Ave. and head straight for 1/8 mile and the Holiday Inn will be on your Left.

#### From New Jersey and points to the East

Take I 95 South. I 95 becomes the New Jersey Turnpike South (Toll Road). Take Exit 6 towards the Pennsylvania Turnpike. Merge onto the New Jersey Turnpike Extension. The N.J. Turnpike Extension becomes the Pennsylvania Turnpike West / I 276 West. Take the Route 309 Exit 339 towards Fort Washington. After the Toll Plaza bear to the Left on to Pennsylvania Ave. go straight for 1/8 mile the Holiday Inn will be on your Left.

#### From Allentown and points North

Take I 476 South toward Philadelphia and South/ East-West Turnpike. Merge onto the Pennsylvania Turnpike East/ I 276 towards New Jersey. Take Route 309 Exit 339 towards Fort Washington. After the Toll Plaza bear left on to Pennsylvania Ave. go straight for 1/8mile the Holiday Inn will be on your Left.

#### From the Philadelphia International Airport (PHL)

Follow the main exit signs out of the Airport, and merge onto I 95 South. Follow I 95 to Exit 7, I 476 North/ Plymouth Meeting. Take Exit 20 for the I 276 East/Pennsylvania Turnpike. Take the Route 309 Exit 339 towards Fort Washington. After the Toll Plaza bear to the Left onto Pennsylvania Ave. Then head straight for 1/8 mile and the Holiday Inn will be on your Left.

#### **One Day Clock Repair Class**

The One Day Class will be on Adjusting Verges on Recoil, Dead Beat, and Half Dead Beat Escapements. This will be a class in which the students will learn the finer points of the physics of the verge and how to make adjustments on the most common escapements. Two pairs of small pliers, a micrometer or digital caliper, magnifying device, a small vise, a small hammer, two staking punches, and an American Kitchen Clock movement with an outside escapement (in working condition) would be helpful but not necessary. Several examples of the escapements and all other tools will be supplied. This class is especially designed for beginners but will also be very helpful for anyone who wants to practice their verge adjustment skills. The students will be required to make adjustments to recoil, half-dead beat and dead beat escapement during the course of the presentation. The instructor will be Dave Gorrell. The cost of the course is still \$10.00 with a pizza and soda lunch provided. The class will begin around 10:00A.M. and last until 3:00 P.M. You may register with the instructor in advance or just show up at the door. The class will be held in the Holiday Inn, Fort Washington. Ask at the desk for directions to the class room.
