## **The Speakers for our Meeting on December 8<sup>th</sup>:**

**The Luncheon Speaker will be: Don Sutton.** The topic is "Early American Watch Companies (1800-1890)".

**The Workshop Presenter will be: Lee Davis.** The topic is: "Gilding on Glass". Lee Davis, 50+ year member of the NAWCC will demonstrate the basic elements of applying gold leaf on glass as was done on early American shelf clocks. The workshop will include several original clock tablets from the 1820's to the 1840's with some insight on how various techniques of design were done.

**Saturday Hands On Workshop** The "One Day Class" for Saturday December 7<sup>th</sup> will be: Bushing a wooden works clock. The class will concentrate on the following: Making wooden bushings and installing them, bone bushings making them and installing them, installing hidden brass bushings, and making and installing sheet brass bushings. Each participant is to supply their own wooden works movement (if they do not have one, one will be supplied by the instructor, contact him in advance at 443 694 4972), a small hammer, and any other tools they think are necessary and/or desirable. The Class will be from 10:00 AM to 5:00 PM with a 45 minute lunch break. The last hour of the class will be "Open Bench" so bring your watch and clock problems and we will endeavor to solve them for you.

**Future One Day Classes.** Please let Jeff Fox or Dave Gorrell know if you are interested in a class on Watch repair. Let them also know of any future topic that you would be interested in covering.

**December Meeting.** With the high turnout we have had for our December meeting, we will be looking to add additional tables for this meeting but we still have a limited amount of space.
