It was also announced that the meeting and breakfast would be at no cost to the attendees. **Bob Butler** indicated that we have a verbal confirmation for the April 21, 2018 *Joint Chapter 11, 12 and 141 Joint Meeting and Mart* at Woodsboro, MD.

Our thanks to the following presenters of our Ugly Clock Contest and Show and Tell:

**Eric Kramer** - In addition to his presentation in his black and red tennis shoes, Eric showed a small bird cage alarm clock.

Bill Bonta – showed a time and strike French alarm clock. What made it unique was that one spring operated both the time and strike mechanisms. Also, when the alarm sounded the clocked stopped, and there was no way to stop the alarm once it started to sound.

**Mike Baron** – showed a Italian Cherry Wine Bottle with a round opening in the center that contained a clock.

Bob Butler - presented a Noah's ark wall clock.

**Frank Blahut** – showed a clock his uncle had made. It was square, and qualified as an Ugly Clock since it did not sell at an estate sale.

Dave Kehne - had a Wolf Clock. Dad was on the top, while mom and the cubs were depicted at the base. It was appropriate for this time of the year since they were shown in snow scene with ice sickles hanging from the eaves.

George Hudson - had an unique "Ugg" boot clock, right foot only. A family member had outgrown the boots and George repurposed them to include a quartz clock movement with the dial on the front of the boot. Since it was the right foot, George said it always showed the "right time".

The voting was intense, but George won by 9 votes. He and his wife get free admission to out next meeting.

In the "Tell" portion of the program Frank Goad showed 3 Hampden railroad grade pocket watches. The first was a 19 jewel dating from the late 1800's. The second had the copyrighted "Railway Movement" on the dial and was dated 1920. The third had a 23 jewel movement and was labeled "Special Railway" on the dial. It was also made in 1920. Frank reported that in the 1930's the company went out of business, was sold to a Russian firm, and all the equipment was moved to Russia.
