

TRAVEL DIRECTIONS TO GOOD COUNSEL CAMPUS

From Long Island and Queens take Whitestone or Throgs Neck Bridge to Hutchinson River Parkway North to I-287 (towards White Plains). On I-287 take Exit 6. Make a left and another left on North Broadway/Rt.22 South. Proceed 6 traffic lights and turn left onto the campus. Straight ahead is a security booth. Turn right, on your right is the sports gym.

From Connecticut and adjoining Upstate NY take Cross Westchester Expressway to I-287 West to Exit 6. Follow the directions above.

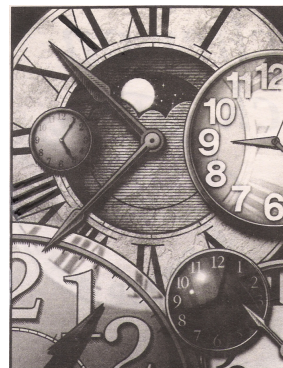
