

### **June 12 HOA Meeting Minutes**



Guests included Chris Langston, with an interest in double dials and weight regulators; Will Harbison, interested in watch-making education; and Doug Kantro, guest of Harry Firth, and contributor to Harry's

display of automobile clocks.

The program was presented by Rev. Canon Harry Firth on automobile clocks. Harry created a very attractive and comprehensive display of automobile clocks to illustrate his program. Harry referred members to the April 2002 and November 2004 Bulletin articles on Waltham watches produced for automobile clocks for further research.

Jerry Thornsberry opened the business meeting with the positive letter of response from the New York State Historical Society for the James Fennimore Cooper Museum, regarding the proposed gift by Chapter 36 of the Natty Bumppoo restored reproduction clock for use in their research library. Harry First moved and Barbara Hohendorf seconded the motion to reimburse Gunther Reinhardt \$150 for his expenses. Motion passed.

Barbara Hohendorf, General Chairman for the River Cities Regional, reported 297 registered attendees, and 124 tables and half tables sold. There were 54 rooms sold at the Radisson, and the breakfast banquet drew 80 people purchasing tickets. Jerry VanLanker reported the Regional account with a beginning balance of \$7,506.85 and ending balance of \$6.770.03, or a loss of \$736.82.

A motion was made by Mike Haines to hold a Regional in 2007. Discussion followed regarding ways to hold a regional at a profit rather than a loss, and whether the Regional generates value for the work involved. Motion passed.

An annual audit report will be prepared for the next meeting. The minutes from the April meeting were approved. Jerry VanLanker reported the Regional account with a balance of \$6.770.03, and the Chapter account a balance of \$1,559.02. Unpaid dues notices will be sent out after the meeting and unpaid members dropped from the mailing list.

Duain Paugh announced a class on movements to be held at Johnson County Christian at 7:00 on July 14<sup>th</sup> and 28<sup>th</sup>. The veneering class will also meet at those times to finish up their session. Duain will run a survey on member interest in specific classes in the August newsletter to help plan classes for this fall and winter.

Wayne Herrmann reported the Restoration Contest currently has 3 entries. "Before" photos were taken at the meeting for those participating. New entrants to the contest will still be accepted.

Several members brought Show and Tell clocks relating to Harry Firth's program. Sam Kutner brought a chronometer, Wayne Herrmann brought a car clock circa 1949, and Bob Hill brought a truck clock called a "squealer" that was used to track a truck driver's driving time. Dan Ward also brought a recent ogee purchase.

The August program will be presented by Bill Dugan, Jerry and Joe Gensheimer on Scottish Tall Case clocks.


### October Meeting in Sedalia "Fall Getaway"

The trip to Sedalia is approximately ninety miles and two hours drive time from the Lenexa Community Center. Plan to arrive around Noon, neal about 1:00.



### Chapter 36



### Educational Programs



Chapter 36 offers a variety of educational programs based on the interests of members. Course numbers and descriptions for current and potential course offerings are listed below. A sign-up sheet is provided so that all NAWCC members may indicate their interests in taking a future course.

- 1. Introduction to Lathe Activities: This entry level course introduces the student to lathe functions and proper techniques for lathe work. Participants will complete one project during the class.
- 2. Intermediate Lathe Skills: This course used skills learned in Course No. 1 to extend the student's ability to complete more advanced lathe projects.
- 3. Introduction to Photo Transfer and Stenciling on Glass: This two day course teaches the student to cut glass and prepare it for the application of lithographs and/or stencils. Students also receive instruction in selecting subjects appropriate to the period timepiece for which the application is made. The student will apply color to the application as he completes projects for personal use in clock restoration.
- 4. Intermediate Photo Transfer and Stenciling on Glass: This class builds on class no. 3, and permits the students to complete more advanced projects.
- 5. Introduction to Veneering: Participants are introduced to various wood types and cuts of veneer as part of the overall veneer selection process. Practice is provided in cutting, forming, clamping, sanding, and gluing veneer. All applications will be made to a practice board.
- **6. Veneering Applications:** Participants use the skill and techniques learned in the Introduction to Veneering class to restore a clock from their personal collections.
- 7. Applying Gold Leaf to Wooden Surfaces: This course uses period techniques to prepare and apply gold leaf to wooden surfaces, such as columns of a clock. Among the activities included are the application of gesso, bole, and gold leaf.
- 8. Stenciling of Wooden Surfaces: The restoration of many antique clocks requires stenciling of the columns, splat, or other surfaces. This course allows the student to learn the techniques while making appropriate applications to wooden surfaces.
- 9. Introduction to Period Finishes: This course begins with a review of the materials originally used in the manufacturing of wooden antique clocks. A study of various colorants and their original use will be studied in detail, and application of selected colorants will be applied to practice pieces. The various types of period sealants will be reviewed (shellac, waxes, ect.) will be applied to the practice board.
