From the President's Desk . . .

Dear Chapter Friends.

At our February executive committee meeting, your chapter officers began what we hope will be at least a year-long effort to promote, explain, and support the "For All Time Endowment Campaign" of the NAWCC. This letter is our first attempt in sharing insights and enthusiasm with you.

The joys and benefits we experience together in the Heart of America chapter are profoundly important as we dedicate ourselves to chapter well-being. Modest chapter growth in connection with the public outreach of our regionals in recent years is most encouraging, in contrast with declines in national membership.

Vastly significant technological advancements have brought rapid life-changing developments, some which are related to the field of horology. Should we be alarmed? Should we feel betrayed by younger generations so easily adapting to alternative life-style possibilities?

We hope not. Far better for challenges to be creatively addressed; positive solutions recognized, studied, implemented.

Nationally, the NAWCC has taken the proactive step of creating the "For All Time Endowment Campaign" which has been featured in the *Watch and Clock* magazine, and which hopes to culminate with the NAWCC's 75th Anniversary in 2018.

An important long-range goal for future viability would assure dependable revenues consisting equally of a) membership dues, b) revenues from Association services, and c) endowment earnings. Importantly, the earnings generated from the endowment funds will lessen the need to depend on members' dues to support the organization.


