# What We Did on Our Summer Vacation

"The Beat Goes On"

Sonny and Cher (1967)

Jim Williams discussed the concept of the "beat" of the movement of a timepiece and demonstrated the regulation of a movement's beat.

Very simply, a movement's beat is an even (i.e., balanced) "to and fro" of the pendulum as heard by its tick and tock. One can hear a clock's beat and determine if an adjustment needs to be made. The easiest adjustment is the raising of one side of the clock until it has a nice even-sounding tick-tock.



Devices exist that can accurately measure the beat (and provide other meaningful information) of a movement in order to aid in its correct setting. Jim demonstrated two of these devices.

The first, "Timetrax Model 50," (\$60 retail) by *Adams Brown Co.*, is a beat amplifier with high gain sensitivity and amplification. It has a volume control on/off slide switch and rechargeable battery (with charger).



All in all, a very good time.


The second device, the "MicroSet Precision 2," by *Mumford Micro Systems* (retail \$275 for the clock version) is an electronic timing device for clocks and watches. It provides extremely accurate beat



information, eliminates false readings from extraneous noise, finds the correct rate of a pendulum clock, records the pattern of strikes over many hours to find intermittent problems. The MicroSet has a computer interface (Mac and

Windows) that allows the recording and storing of the movement's data. A version of the MicroSet exists for use with watches.


Also useful to determine the beat of a clock is the *Clockmaker's Beat Book*, by Jeff Hamilton (\$19.95, direct from the author at www.clockmaker.com).



Switching gears, Jim also demonstrated the ease of polishing of metals and removing rust with a bench lathe by Foredom Electric Co. (\$215 retail, from www.foredom.net) using 3M radial bristle



discs (extra). Many attachments and tools are available for sanding, grinding, and polishing such as brushes, mandrels, discs, drills, burs, chisels, etc.





# Chapter 57 Meeting and Potluck Meal

Let's join our friends from Chapter 57, Ozark, at the historic home of Ruth and Hugh Overton. The meeting and mini-mart (11AM) and meal (noon) will be outside. Conducted tours of Hugh's clocks and the home will be after the meal.

The Overton home, and matching carriage house, were built for James Luke in 1900, in the Classical Revival style, of golden yellow brick imported from England. Mr. Luke was a native of Cornwall, England. He came to Missouri in 1874 and became a prominent Carthage property owner, mine operator, and philanthropist.

W.H. Woestman purchased the home in the 1940s and raised his family. Mr. Woestman was a vice president of the Steadley Co., a manufacturer of springs for the bedding and furniture industry in Carthage. His widow lived in the house until the 1980s.

The Overtons purchased the home from the Woestman family in 1985 and have restored it to its former grandeur.
