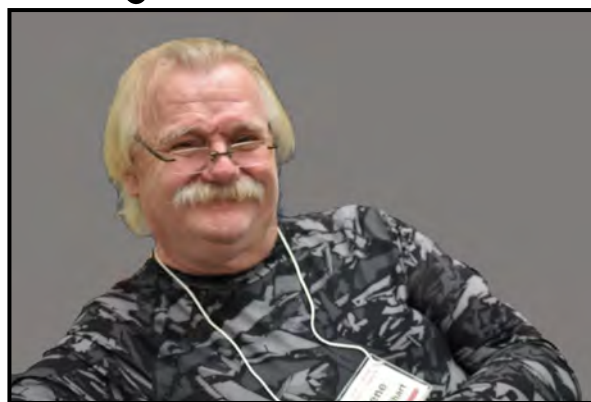

### Treasurer's Report

The Treasurer's report, as printed in the December 2019-January 2020 newsletter, and amended because numbers were not contained in the Treasurer's Report that was printed in the newsletter, was approved by the members. This oversight was explained at the meeting.

### President's Report

Harold Engelhaupt continues to improve and sends his best wishes to members.

The President discussed the need and importance for new officers inasmuch as only one office out of five had a nomination (Lisa Shepard, Treasurer). The meeting paused for cake and drink. Afterwards the election of officers proceeded.

### Election of Officers

Officers for the 2020-2021 term were elected thanks to two members who rose to the occasion. They are: Gene Geiselhart, President and Thaine Damman, 2nd Vice President. Lisa Shepard was re-elected Treasurer and *temporary Acting Secretary* (IMPORTANT: Lisa Shepard has agreed only to take the minutes of the chapter's meetings.) The offices of 1<sup>st</sup> Vice President and Secretary remain to be filled.

### Report

Wayne Andrews recently performed maintenance to the Winkler clock, with Lisa Shepard and Judge Robert Serra observing.

## 50/50

Wayne Andrews officiated the 50/50 drawing. The winner was Mike Haines. Dan Haines accepted for Mike while he was out of the room and donated Mike's winnings to the Education Fund. The chapter's Education Fund increased by \$64.

## Treasurer's Report

NAWCC Chapter 36 - Bank balances on January 27, 2020:

- ♦ \$1,080.22—"chapter" checking account, and
- ♦ \$27,252.34—"regional" checking account. (This total now includes the entire balance of the Education Fund of \$2,788.00 \*)

The "checking" bank account transferred \$2,056.00 to the "regional" bank account in December. Of this, \$1,056.00 relates to the Education Fund, and \$1,000.00 is the return of a previous transfer TO the "checking" bank account (October 2017).

The only activity in the "regional" bank account were the above transfers.

The "chapter" checking account reflects proceeds from the December 50/50 drawing (\$64.00), 2020 dues and donations to the chapter (\$525.00), sale of unused sparkling grape juice (\$21.00); minus the purchase of newsletter stamps (\$44.00), cake and drink for the December meeting (\$110.05), and the above transfers.

The annual 2019 financial statements will be presented in the next (April) newsletter.

\* The balance of the Education Fund is \$2,788.00. This balance is now entirely contained within the "regional" bank account. Should the balance in the checking account go below \$1,000.00, a service fee will be charged by the bank. We can discuss this further at the meeting.
