How are you doing? Are you available for assistance? I am out of the state now, and I have absolute confidence in you to handle this. The Valley of the Sun Chapter of the NAWCC needs to purchase gift cards to make donations to Veterans in Hospice and Palliative care units to buy coronavirus disease (COVID-19) prevention items. I'm responsible for the reimbursement. Would you like further information?

AOL is my primary email provider. When I hovered my cursor over the sender's (Jim's) name, the sender's email address appeared, and it wasn't Jim's email address! What seems to be a legitimate request is actually a phishing attempt that, if acted upon, could result in losing your bank card or other personal information.
