

In Memorium

Bob MacIver died February 13, 1996 aged 84. Bob devoted his entire life to his family and over the past forty-five years he added the filed of horology. Over the course of the past forty years Bob was an active member of NAWCC, the Dr. Stephen's Chapter #5 and our own Chapter #107. Bob served both chapters numerous times in various board and executive positions. He has written several articles for the NAWCC bulletins and was always willing to write for the local bulletins as well as making local chapter program presentations. Bob was instrumental in the very successful Regional display at the 1980 San Francisco Northern California Regional and received his Fellowship from the NAWCC in 1983. Bob was very talented and not only in clock and watch repair but was also extremely talented in wood and metal working. This skill was recognized with the following awards in the NAWCC National Annual Craft Competition.

- . Metal Clock Case Blue Ribbon June 1987
- . Solid Wooden Case-Red Ribbon June 1987
- . Solid Wooden Case Blue Ribbon February 1988
- . Other Material Case Blue Ribbon June 1989
- . Horological Novelties Blue Ribbon July 1990
- . Original Case Design Red Ribbon June 1991
- . Original Case Design Red Ribbon July 1992

Bob was preceded in death by his wife, Clemence A. MacIver who died last December 1st, also a long time member of NAWCC.

Bob was born on April 21, 1911 in Mamaroneck, New Jersey. He graduated from Aurora High School, Hobart, Indiana in 1928 and later studied mechanical engineering at the University of Arizona. During the Depression as many did he left school and continued working. Shortly after a visit to the San Francisco area for the World

Fair of 1936, Bob and Clem moved from Arizona to Alameda, California. Here, Bob continued his career as a graphic print setter for several major San Francisco Bay Area news papers. Bob was an Honorary Life Member of the International Printing and Graphics Communications Union.

After retirement in 1975, he dedicated most of his efforts taking care of his beloved wife and then to his love of horology. Bob was recognized by many local members as a valuable resource for clock and watch information, repair techniques, case repair and wood and metal working.

To many friends, Bob was best known for his abundance of hot coffee, good pie and great conversation. He was always willing to sit down with anyone willing to talk horology and pass the hours until the early morning discussing any related area of clocks or watches. The informal meetings and discussions often reminded me of the old Chapter meetings I had read of in early bulletins where groups would meet and just enjoy talking about the art and craft of the love of horology. Bob will be greatly missed for the wealth of knowledge he possessed and his willingness to share. I encourage everyone to take the time to talk and listen to our long time members, to gain some of their wisdom and to nurture that knowledge so that it can be passed onto yet future generations of horologists. For his knowledge and friendship, I will always be grateful to Bob.

Henry B. Fried 1907- 1996 CMW, CMC, FAWI, FBHI, FNAWCC

Henry B. Fried died just two days before Bob MacIver. He was known as the Dean of American Watchmakers and taught at the City College of New York for over thirty-five years. For decades he was the watch maker whom others consulted on the really tough cases, a fact he attributed to his "tweezer skills". He received almost every honor in his field and the one bestowed last Fall meant more than most. The clock tower at the new headquarters of the AWI near Cincinnati was dedicated in his honor. He was a prolific writer and wrote the Q&A lead article in the AWI publication, "Horological Times". Henry also sponsored and headed horological tours to Europe and Russia and had access to collections and factories that were very rare and exclusive.
