



EXECUTIVE COMMITTEE Meeting Minutes

March 7th 1994 Board Meeting - Bill Koppel presiding

The second Executive Committee meeting of '94 was held at Bill Koppel's house on March 7th.

Attending: Bill Koppel, Bob Boone, Roy Clark, Walt Hubrig, John Stohr. As a quorum was not present the meeting continued as an informational meeting.

Treasurer Walt Hubrig reported that he had re-invested the Chapter's CD when it came due on 2/15/94. The Chapter now has a 6 month CD paying 3.0%, a one year CD paying 3.3% and an 18 month CD paying 3.75%. These investments were made after \$1,000 was transferred to the Chapter's checking account to cover the Tool Library purchases.

The PO Box rental for another year has been paid.

The checking account was moved to a non-interest bearing account as the interest was not covering the Bank charges when the balance was below \$1,500.

The April meeting program will be a report by Larry Bernard on his Great Britain Horological Tour.

John Stohr mentioned that a request will be in the Bulletin by an Illinois NAWCC member who is looking for information on AURORA watches and also a request for clocks and watches to be displayed at the Museum of American Heritage.

Future copies of the Chapter Bulletin will be sent to our National Awards Committee representative in Southern California.

The meeting adjourned at 2110hrs.1

"The Ansonia Clock and Rubber Company"

The Beginning

There is little question that the Ansonia Clock Company was the most productive and innovative clock maker in the USA - bar none. It started from a small beginning in May 1850 when Anson G. Phelps of Phelps-Dodge & Company and Theodore Terry and Franklin C. Andrews (Terry & Andrews) formed a joint stock corporation at Ansonia, CT near the town of Derby. They called their business "The Ansonia Clock Company" - (why did a brass company get involved with clocks?). In 1850 Terry & Andrews used fifty tons of brass for clocks.

In 1849 Chauncey Jerome was making clock cases on Main Street and E. D. Bryant was making clock movements - the clock business thrived.

It was back in 1844 that Anson Phelps built a dam near Derby CT. and built the factories of Ansonia Brass and Copper Company. The officials of Derby refused to let the factories - nor any factory expansions to be built within Derby's city limits. Anson Phelps bought land outside the Derby city limits and as Anson said "I'll name the new town after myself" - and he did. Ansonia CT. was born.

In November 1854, the original Ansonia Clock Company buildings burnt to the ground. The ruins were sold to you guessed it - Phelps Dodge Corporation. (Dodge was Mr. Phelps' son-in-law) Over the next 15 years only a few clocks were made. As per my reference material. The name used was 'Ansonia Brass Company' and later 'The Ansonia Brass and Battery Company'. Why the "battery" name? The name battery came from the process of pounding the brass so that it could be shaped into various brass objects. It was a very noisy process.

In this 15 year period from 1853 to 1869 there was no official clock company name as we could find. Phelps, Dodge & Co. did make movements and sold some cased clocks but there number was minimum.

Clocks were labeled 'Asonia Brass & Battery Co.' The label showed a picture of the factory that had burned in 1854.

For a year from 1869to 1870 clocks were labels 'Ansonia Brass & Copper Co.' It was on December 21, 1877 that the original name of 'The Ansonia Clock Co.' was restored. It was very evident that a re-organization was needed. this was done when the Ansonia Clock Co. consolidated and merged there business with that of Mr. Henry J. Davies, who was manufacturing clocks and specialties in New York City. Mr. Davies address was at 11 Courtland and 11 Cliff.

A new joint stock corporation was formed under the name of the 'Ansonia Clock Co.' with Mr. Davies as the General Manager. Mr. Davies' brothers, Walter D. Davies and Edward Davies were named as Superintendents of Works.

In 1880, a new huge factory was built in Brooklyn NY. On October 27, 1880 the new building was completely destroyed by fire. It was immediately rebuilt after some redesign to increase work space.

The Ansonia Rubber Company

By 1881 the American market for rubber goods had increased. On April 21st 1881 the Asonia Clock Co. purchased the 'College Point Rubber Co.' of New York and was renamed the 'Ansonia Rubber Co.' with Henry J. Davies named as President. (He retained his position as General manager of the Ansonia Clock Co. Other Rubber Company officials were J. Van Vleck as Vice President and Herman Gelpcke as Secretary. The company was organized for the general manufacture of Hard Rubber or Vulcanite Goods various articles of rubber were produced.

Specific rubber products manufactured by the new company was a new line of 'Black Rubber Clock Cases' and distinctive 'Rubber Dials' for the cases. Of course the Ansonia Clock Co. furnished the movements. We have seen two of the Ansonia 'Marbleite' case models made with rubber. The rubber dials are not all that rare - we have seen many of them. The Rubber Co. failed in the depression of 1884 and the land and most of the machinery was sold off in bankruptcy proceedings. In 1929 the Ansonia Clock Co. was sold to Russia. The Ansonia Co. in Washington only has the name - no records etc. of the original company.
