President's Column

Twenty four members and guests attended our August 28th meeting at the **Pickersgill Retirement Community.** We were joined by several members of the community for our program.

After breakfast and a short business meeting, the following members shared with us their summer horological finds:

Frank Blahut - a quartz Kundo clock with a 400 day type pendulum. Frank got clock, which was not working at a white elephant sale for one dollar. He was pleasantly surprised that it came to life when he installed a new battery.

Bill Miller - A 1950's German made Hettich battery operated clock with a balance wheel (with 8 rating screws) mounted on a tension wire, and a double wound helical suspension spring which beats seconds. The clock is supposedly capable of being timed to seconds per week.

Tom Mostyn - Started to restore a friends large French clock. The friend moved and they lost touch. After 30 years they reconnected, and the friend gave the clock to Tom. Tom is currently completing the restoration of his clock.

Jim Manning – Described his \$3 flea market find. A Swiss made Le Jour, circa 1970, 2 register chronograph wrist watch with an uncommon outer bezel calibrated for miles traveled. The watch was sluggish in operation, but was sold as is on e-Bay for \$500. They are still finds to be found, if you can spot them.

Ed Butler - Shared with us his WW1 US Air Service pocket watch, with a Swiss movement, that was sold by the French to the US Government.

George Hudson – George did not have a horological find, but he showed us how to braid a rope to create an endless rope that was used on some early clocks.

Then it was the ladies turn to spill the beans on their spouses:

Bobbie Hudson – related the saga of a 2003 auction in which George purchased a tall case clock. Weather forecasts indicated rain on the trip home, and the pick-up truck was uncovered. They carried the clock into their hotel room and wrapped in multiple layers of plastic. the clock was so bulky that it could not be stood upright, and the only place to put it was on one of the
