## Minutes of Freestate Chapter141 – May 13th, 2016

Chapter 141 held their bimonthly meeting at the Mountain Gate Restaurant in Thurmont, Maryland with 22 members and guests participating. As usual, there was a mini-mart, and I'm happy to report that some items changed hands to the delight of both buyer and seller. President **Lou Orsini** opened the meeting with Vice President **Neil Amrine**, Treasurer **Darcy Bertelmann**, and Webmaster **Alex Snouffer** providing updates. **Wheeler Green** won the 50-50.

Among the issues discussed was the recently concluded annual tri-chapter meeting in Woodsboro, and an update on the medical status of one of our members who was injured. It was decided that the Chapter needs a point of contact to send get-well and sympathy cards to members when appropriate, and **Deanne Mostyn** volunteered to take on that responsibility.

Sam Morataya, a watchmaker and co-owner of *Afram Jewelers*, which is a family-owned and operated business in Washington DC, was our speaker. Sam enthralled the audience talking about how he became interested in watchmaking, which started in 1999, his training and experience, and how the store operates. Being directly across the street from the White House, the store gets a lot of business from people who work there including

President Bush and Vice President Biden, although they didn't always know who owned the watches until after the repairs were completed. He said that Bob Dole was one of the funniest customers he ever had. The store is primarily a jewelry store, but it also is a full service watch repair shop. Sam has two benches full of repair work in process at any given time, and typically has a 4-6 week backlog of work. His wife is a gemologist for the store, and his 86 year old father-in-law still does watch repair part time to help out. Most of their business comes from word-of-mouth and personal relationships they've built over time. He showed us an In-Store magazine article describing the energy efficient lighting the store recently installed, which he described as a vast improvement in visibility for customers when examining jewelry. Apparently it also works fine for watch repair.

Much of the program consisted of a robust question and answer session, which everyone thoroughly enjoyed. The next Chapter meeting will be September 8.
