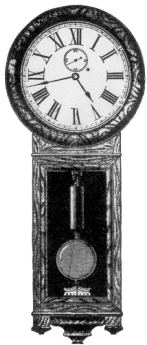

Directions to the Edmond Town Hall, 45 Main Street, Newtown, CT 06470:

FROM HARTFORD ON ROUTE 84: Exit 10, turn right to Route 6*** travel about 1.5 miles to Route 25. There is a large flagpole in the center of the road, turn right on to Route 25. ### Edmond Town Hall is on the left (100 yards from the flagpole). Parking is in the rear of the hall as is the entrance to the Mart.

FROM NY ON ROUTE 84: Exit 10, turn left on to Route see *** above.

FROM NY ON ROUTE 15 (MERRITT PARKWAY): Exit 46, turn right at the light at the end of the exit, turn right again onto Route 59, proceed about 4 miles to the first stop sign. Turn right staying on Route 59 for approx. 4 mi. to traffic light; turn left onto Route 25. It is about 7 miles to the flagpole in Newtown. See ### above.
