April Chapter Meeting:

The April Chapter meeting was held via Zoom and was attended by 8 members. Bob Arnold opened the meeting, welcoming the attendees, including a potential new member named Rick Nims. This was followed by an interesting presentation by Andy Dervan on the Grand Rapids Clock and Mantle Company.

In 1890, the company was founded by James T. Phillips and Eli E. Dryden in Grand Rapids. The business started with twelve men on the corner of South Front Street and Shawmut, and its factory grew in size to meet business demands and had fifty-four employees in 1906. The company submitted articles of association on September 21st 1893 as Dryden-Annin-Rose Clock Company. On November 30th 1894, James T. Phillips, President and Charles H. Annin, Secretary filed articles of association to change the corporation's name to Grand Rapids Clock and Mantel Company. In 1908, the company purchased Victoria Hall Clock Company in New York City. Its President was Philip H. Klein Jr. and he was awarded a U.S. Patent No. 938,388 for a Chime-Clock that was assigned to James T. Phillips, Grand Rapids Clock and Mantel Co. Examining examples of the company's movements, it appeared the company was utilizing Klein's patent.

A reference in the 1910 Weekly Artisan reported the company had 24 employees, and it noted Rapids Clock and Mantel Co. ca 1897-1916 advertised English Hall Clocks in 1897; Art Mantels and Hall Clocks in 1909; made "Mission, Colonial, and Dutch Style clocks". The company appeared to be successful manufacturing its clocks and mantels in early 1910's based on its catalogs. On January 8th 1918, Henry L. Adzit and Geo F. McKenzie filed a Notification with Michigan Corporation & Licensing officially closing the corporation and selling off its assets.

The company published at least two catalogs. One was titled "Fine Hall Clocks and Art Mantels" and illustrated their product mix and depicted an image of their factory. The second catalog titled "The Height of Elegance in HALL CLOCKS" focused exclusively to their line of chiming Hall Clocks.

The author has seen a limited number of these chiming hall clocks and they have 9 tube movements. These Mahogany case 9 tube chiming hall clocks were \$ 480 to \$ 1100.

After some questions and discussion, Tom Morris showed how he made a new scroll for a Silas Hoadley pillar and scroll clock. This clock, made around 1825, is still in mostly original condition except that the scroll had been replaced at some point. The style and construction of the replacement scroll was not consistent with what would have been on the clock originally. The challenge was to make a new scroll of appropriate material, construction, and design that would be true to the original scroll, but match the patina of the rest of the clock. After removing the existing scroll, corner towers, and returns, a new scroll was made using a pattern from another Hoadley pillar and scroll clock. The new scroll was made from poplar and veneered with the grain vertical consistent with construction in that time period. After dying the parts a dark brown to match the case and applying a topcoat, the new parts were reinstalled. The clock now looks period correct and still retains its original look.

The meeting ended after some general discussion and catching up by the members.
