become interested in clocks and pocket watches and had taught himself to do servicing and repairs. Since he had serviced a 12 size pocket watch, he decided to tackle the wrist watch repairs since they weren't much different in size. Upon disassembly, he realized that the watch was more complicated since it was auto wind and had a day/date calendar feature. There was salt residue evident in parts of the movement from the dip in the ocean, so the watch was completely disassembled and thoroughly cleaned in an ultrasonic cleaner. The watch was reassembled and oiled, but it would not run, so more cleaning was done. Maurice determined that the pallet fork was not getting clean enough and was hanging up when the roller table tried to rotate through, so more targeted cleaning was done to this part and eventually the watch would run and keep good time. This project took 20-30 hours to complete over a period of three months. The presentation included many detailed photos of the entire process and Maurice was wearing the watch at the meeting. The presentation concluded with several questions from the audience.


