# **April Chapter Meeting:**

The April meeting of Great lakes Chapter Six was held on April 24th, 2022 at the Plymouth Historical Museum in Plymouth Michigan. Twenty six members, wives and guests attended on a beautiful, sunny, warm (finally) spring day. Several members brought items to sell or trade and there were refreshments and lots of catching up among the attendees.

The program began with some opening remarks and announcements from President Ray Fowler followed by introduction of member Tom Morris, who gave a PowerPoint presentation called "To Restore or Not to Restore, That is the Question". The purpose of the presentation was to familiarize the members with the

options they have when deciding what to do with a new acquisition. The presentation focused mainly on clock cases and talked about four main options; preservation, conservation, restoration, and leaving as found. These terms were defined and discussed in detail with examples. The presentation also discussed evaluating your recent clock acquisitions to be able to decide which of the options you want to pursue. Tools and materials that can be used in conserving and restoring were also discussed as well as resources available to learn about the processes that are involved. Several pictures of clocks were shown to illustrate the various options. The presentation concluded with several questions from the audience.



Following the presentation, Andy Dervan spoke about some clock books that he recommended. Of special interest was a book on clockmaker Joseph Ives by Mary Jane Dapkus, a very active NAWCC and Cog Counters member and author.

Light refreshments were provided during the meeting. We have been using individually wrapped refreshment items due to Covid concerns. Hopefully we can return to more fresh food items in the future.


#### Member Questionnaire:
